- 1. Call Meeting to Order: Meeting called to order at 6:32.
- 2. Roll Call Attendance: Strikwerda, Hooper, MacDonald, Gregory (Hammond absent)
- 3. Pledge of Allegiance: Led by MacDonald.

- A. 2014-2015 PD Schedule Title II funds will help pay for training. There will also be some curriculum training. In the Spring, a team will attend Title I training in Salt Lake City. Purchased Milepost Program including training.
- B. Enrollment Update Budget based on 467 ADA (last year). Currently, total enrollment is 498, with potential for growth (still pulling names off waiting list to fill grades K-7).
- C. New Hires Ms. Bell, Ms. Aitchison, Ms. Olsen. Have also hired new support staff. Strikwerda moved to approve contracts for new staff. Gregory seconded. All aye, motion carried.
- D. Upcoming Events; Open House, Parent Teacher Conferences Open House September 9, 6:00 pm. Character awards ceremony September 26. Parent-Teacher conferences Oct 2, 3. Harvest Festival Oct 24.
- E. 2014-2015 Start-up Meet the Teacher last week, very well-received. Good start to the year.
- F. Accreditation Update Accreditation has been received from AdvancEd for grades K-8.
- G. School-Wide Title HCCS is now a school-wide Title I school, so can now work with any students that need assistance.

- E. Executive Session §67-2345(b) Hooper moved to enter executive session. Gregory seconded. Roll call Frans, Strikwerda, Gregory, MacDonald, Hooper All aye, motion carried. Entered executive session at 7:56. Executive session ended at 8:14.
