HCCS Compensation & Benefits Description

- Teacher will be paid on a twelve month, monthly pay schedule based on a 190 day academic work year, all regular withholdings to apply, beginning September 25, 2011.
- Regularly scheduled pay dates will be in accordance with HCCS practice which is currently on the 25th day of each month unless, the 25th falls on a weekend or holiday. In such case, payday will be the work day preceding such weekend or holiday.
- Teacher may take a total of eight (8) days of sick leave during the academic work year. However, except in cases of emergency, Teacher must notify the principal of the absence as soon as possible.
- 4. Teacher may take a total of two (2) days of Paid Time Off ("PTO") during the academic work year. However, except in cases of sickness or emergency, Teacher must obtain prior approval from the principal for all absences.
- Teacher may carry over to the following academic work year up to five (5) days of unused PTO.
- Academy holidays are established annually by the Board of Directors and set forth on the HCCS
 academic calendar.

Although it is intended that the relationship between Teacher and HCCS will grow and be in the best interests of both, Teacher is employed pursuant to the terms of the Idaho State Department of Education's approved Teacher's Contract. HCCS and the Teacher retain all rights and responsibilities contained in the approved contract.
